 - A. Frank Young Trail Extension (Including to the Blinking Light) Update** — It will be resurfaced. Village for a grant from blinking light to Camino Real to Allen Fields, to HS, Allen Fields to existing FY trail. There is a delay, it might have to go into next year.

 - B. Signage for FY Ext.** - Brian will give village signage verbiage but village won't do anything until they are ready to build. We can look at his verbiage next meeting and we can vote. Kiosks only done by Resort, not village. Will name the branches of the trail Frank Young Spurs.
